We are a Gibraltar registered insurance company regulated by the **Gibraltar Financial Services Commission (GFSC)** and authorised to operate in the **United Kingdom**. We are committed to complying with applicable data protection and e-privacy laws, including the **Gibraltar Data Protection Act 2004**, the **UK General Data Protection Regulation (UK GDPR)**, **UK Data (Use and Access) Act 2025**, and the **Privacy and Electronic Communications Regulations (PECR)**.

What are Cookies?

Cookies are small text files that are stored on your device (computer, smartphone, or tablet) by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Cookies alone cannot be used to identify you and the cookie itself does not keep any of the data it collects.

Before the Website places any Cookies on your computer, you will be presented with a pop-up requesting your consent to set those Cookies. You may, if you wish, deny consent to the placing of Cookies; however certain features of the Website may not function fully or as intended.

This Website uses analytics services. Website analytics refers to a set of tools used to collect and analyse usage statistics, enabling us to better understand how Users use the Website. This, in turn, enables us to improve the Website and the products and/or services offered through it. You do not have to allow us to use these Cookies, as detailed below, however whilst our use of them does not pose any risk to your privacy or your safe use of the Website it does enable us to continually improve our business.

Types of Cookie We Use

Strictly Necessary – These cookies are essential for the functioning of the website and cannot be switched off in our systems. They are usually set in response to your actions, such as setting privacy preferences, logging in, or filling out forms. The information these cookies collect is anonymous and they can't track your browser activity on other websites.

Performance / Analytical – These cookies collect information about how you use our website, like which pages you go to most often, how long you stay on them and if you get error messages. They don't collect information that can identify you – we only use them to improve how our website works.

How Long Cookies Last

- **Session Cookies** – Deleted when you close your browser.
- **Persistent Cookies** – Remain on your device until they expire or are manually deleted from your device's cache.

Cookie Consent and Control

You can choose to enable or disable Cookies in your internet browser. Most internet browsers also enable you to choose whether you wish to disable all cookies or only third-party cookies.
